High Brenfield Wind Farm Community Shared Ownership:

lain MacNicol spoke about a joint initiative with other local communities led by Tayvallich Initiative around High Brenfield Wind Farm Community Shared Ownership. This is at a very early stage and planning permission has not yet been granted. Iain explained that funding was available in the form of a loan to buy shares and would be paid back once dividends for shares were realised. It would mean that small communities would have annual income from this venture. He assured members that no decisions would be taken without a community consultation.

The meeting closed and the Chair thanked the attendees for coming with a special thank you to Scottish Canals for the use of the Egg Shed facilities.
